1.1 Information You Provide Directly

Account Information

- Name (from Google OAuth)
- Email address
- Google account identifier (Through Firebase Authentication)

Images, Videos, and User Content

When you upload images, videos, or hints for scanning, these materials are transmitted securely to our backend for analysis. This may include:

- Photos and videos of items
- Metadata embedded in media files

- Text hints you provide
- Session names, notes, tags, and item updates

Subscription & Billing Information

When you purchase a subscription:

- Stripe, Apple, or Google may process your payment information
- We do not store full credit card numbers

1.2 Information Collected Automatically

Device & Technical Data

- Device model, OS version, IP address
- Unique device identifiers
- App version, crash logs, diagnostic data (via Sentry)

Usage Data

- Scan counts, session metrics
- Feature interactions (e.g., history views, settings changes)
- Subscription status and entitlements

Log Data

Our servers automatically log requests and actions performed within the App, including:

- Timestamps
- API calls

Authentication events

1.3 Al & Image/Video Processing Data

When you submit media for analysis, it is processed through:

- Cloudflare Workers (request routing and security)
- Google Gemini AI (image analysis, valuation estimation)

Media is transmitted securely and may be temporarily retained for:

- Al inference
- Quality improvement
- Fraud prevention
- Debugging and performance analysis

We do not use your media to train publicly accessible models.

2. How We Use Your Information

We use your information strictly to operate, improve, and secure the App, including:

2.1 Core Functionality

- Identifying and estimating values of items
- Storing your scans, history, and sessions
- Providing ROI and portfolio analytics
- Delivering personalized suggestions or UI optimizations

2.2 Improvements & Development

- Enhancing Al accuracy
- Debugging issues, improving performance, maintaining security
- Evaluating feature usage for roadmap decisions

2.3 Fraud Detection & Abuse Prevention

- Preventing automated or abusive scanning
- Detecting anomalous usage patterns
- Enforcing commercial use restrictions

3. How We Share Your Information

We do not sell your personal information.

We share data only with trusted third-party service providers essential to the operation of the App.

3.1 Legal Compliance

3.2 Business Transfers

If we undergo a merger, acquisition, financing, or sale of assets, your data may be transferred as part of the transaction, subject to this Policy.

4. How We Protect Your Information

We implement industry-standard security measures, including:

- Firebase security rules
- Access controls and authentication safeguards
- Secure API gateways
- Regular security monitoring

However, no system is fully secure. You use the App at your own risk.

5. Data Retention

We retain data for as long as necessary to:

- Provide the Service
- Maintain user accounts

- Comply with legal obligations
- Improve AI accuracy and performance

If you delete your account:

- Personal identifiers are removed
- Associated content is deleted from Firestore
- Backups may persist for a limited period (up to 90 days)

6. Your Rights & Choices
